INVITATION FOR BIDS (IFB)

The Government of Kenya has received financing from the World Bank towards the cost of **Water and Sanitation Development Project (WSDP)** and it intends to apply part of the proceeds towards the payments for the **Rehabilitation / Extension of Mombasa Water Supply Distribution, Contract No. (KE-MOWASCO-16769-CW-RFB)**.

1. The Mombasa Water Supply & Sanitation Company Limited now invites sealed bids from eligible and qualified bidders for **Rehabilitation / Extension of Mombasa Water Supply Distribution**. The construction period is 30 months (inclusive of 12 months' defects liability period). The scope of works comprises the following:
 - i. Laying of approximately 40km of ferrous pipes and pipe fittings ranging between 150mm to 500mm diameter.
 - ii. Laying of approximately 16km of uPVC pipes and pipe fittings ranging between 110mm to 250mm diameter.
 - iii. Supply and installation of Zonal Meters
 - iv. Ancillary Works including but not limited to Construction of Valves and Meter Chambers.
2. Pre bid meeting and site visit will be on the **29th of November, 2018** at **0900hrs (EAT)** at Mombasa Water Supply & Sanitation Co. Ltd, Mikindani Street, Off Nkrumah Road, Mombasa
3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank's Guidelines: Procurement of Goods, Works and Non – Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January 2011, revised in July 2014, and is open to all bidders from Eligible Source Countries as defined in the Guidelines. In addition, please refer to paragraph 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
4. Interested eligible bidders may obtain further information from the address given below; from 0800 hours to 1630 hours' local time from Monday to Friday, except during lunch hour (1300hours to 1400 hours), during weekends and public holidays.
5. A complete set of Bidding Documents in English may be downloaded free of charge from the **Mombasa Water Supply & Sanitation Co. Ltd Website (www.mombasawater.co.ke)**. Bidders who **download the bidding documents are required to notify the purchaser by email: info@mombasawater.co.ke with full contact details that they intend to participate, this will facilitate issuance of notifications by the purchaser to all bidders where necessary**. No arrangements have been made for other methods of delivery of bidding documents.
6. Bids must be delivered to the address below on or before **1100 Hours EAT on 8th of January, 2019**. The packages should be clearly marked **"Rehabilitation/ Extension of Mombasa Water Supply Distribution; Contract No. KE-MOWASCO-16769-CW-RFB"** and placed in the Tender Box located outside the **Managing Director's Office**. Electronic bidding will **not** be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders or their representatives who choose to attend in person at the address below at **1100 hours EAT** local time on **8th of January, 2019**.
7. All bids shall be accompanied by a Bid Security (unconditional bank guarantee) of **Kshs. 12,000,000 (Kenya Shillings Twelve Million only)**
